



## **School Parent and Family Engagement Policy**

### **School Year 2022-2023**

In support of strengthening student academic achievement, Mound School receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. #### **A. ANNUAL TITLE I MEETING**

Mound School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

- Mound School will host the Annual Title I Part A Meeting in September of 2022 during Open House.

## **B. FLEXIBLE NUMBER OF MEETINGS**

**Mound School** will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening.

## **C. JOINTLY DEVELOPED**

**Mound School** will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

Mound School will utilize:

- Monthly Chat and Chew Meetings to discuss Family engagements programs, and Title I Part A required documentation with parents and other Caregivers. The school will then plan activities with families that align with their needs and is outlined in the School's Academic Achievement Plan.
- Family Engagement Committee meetings in support of planning Family and Community Engagement.

## **D. COMMUNICATION**

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

**Mound School** will take the following actions to jointly develop with parents and family members of enrolled children a school-parent and family compact that outlines how parents, families, school, staff, and students will share the responsibility for improved student academic achievement and develop a partnership to help children achieve the state's high standard and how the plan is used, reviewed, and updated.

*The Educators of Mound School will develop this document during staff meetings, and will work with a group of scholars to come up with ideas to add in the student's section of this document. Educators will collaborate with Parents during the monthly Parent Advisory Committee Meetings to ensure completion.*

**Mound School** will build the parent and family capacity for strong family engagement to ensure effective engagement of parents and families and to support a partnership among the school and the community to improve student academic achievement through the following:

- Provide assistance to parents and families of enrolled children, as appropriate, in understanding topics such as the following:
  - the State's academic content standards,
  - the State's student academic achievement standards,
  - the State and local academic assessments including alternate assessments,
  - the requirements of Title I, Part A,
  - how to monitor their child's progress, and
  - how to work with educators to improve the achievement of their children.
- Educate school personnel, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents and families,

in the value and utility of the contributions of parents and families, and in how to reach out to, communicate with, and work with parents and families as equal partners, implement and coordinate parent and family programs, and build ties between parents, families, and the school.

- Coordinate and integrate parental and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as family resource centers and materials that encourage and support parents and families to fully participate in the education of their children.
- MoundSchool will host the required 2 events per Quarter as laid out by the FACE office
- The Family Nights/Parent Meetings will include topics aligned to the school's Academic Achievement Plan such as inquiry Informational meeting that will focus on the schools newly adopted made in the second year, Family Math Nights, Family Literacy Nights, K-3 Grade Parent Meetings with a focus on the 3rd Grade Reading Guarantee.
- Mound School will also support families with Grade level transitions such as 8th Grade transition meetings
- Mound School will also host grade level meetings that will be led by the respective educators of the classroom.
- Mound School will host the Quarterly scheduled Parent-Teacher Conferences to update families on Scholars Academic Standings.
- Mound School will provide workshops for parents based on their needs
- The school will host resource fairs to provide families with opportunities to take advantage of the resources that are available to them.

## **H. ACCESSIBILITY**

Mound School in carrying out the parent and family engagement requirements of this part, to the extent practicable, shall provide full opportunities, for the participation of parents and family members (including parents and family members with limited English proficiency, parents and family members with disabilities, and parents and family members of migratory children), including providing information and school reports required under section 1111 in a format, and to the extent practicable, in a language such parents/caregivers understand.

Mound School will provide materials, in a format that is accessible to all stakeholders in the school community (Spanish translations as needed).


