Contractor Network Account Extension Guide

Introduction


Forefront Identity Manager (FIM) has an online extension feature that provides the contractor's CMSD Manager access to extend a contractor's access to the CMSD network. The following automated notification is sent to the contractor's / consultant's manager two weeks prior to the network access expiration date. If you do not wish to extend the access, please do nothing. Email secadm@clevelandmetroschools.org if you wish to terminate access at any time or would like to extend access for a time period less than 90 days.

Steps

Extend Contractor / Consultant Network Access

1. To access your direct reports, enter the following address into your web browser while logged onto the CMSD Domain, using Internet Explorer only. Your screen should look similar to the following with a view of your direct reports. To open the contractor's profile, double click the name of the contractor that you would like to extend access for another 90 days. FIM Portal

If you do not see your direct reports, click on the "My Direct Reports" link on the left side of the screen.



2. Click on the "Contractor Info" tab. Check the box next to "Renew End Date" to extend the contractor's access for another 90 days.



3. Click **Ok** on the bottom of the screen.



Click Submit to complete the process.



5. Finished . . . you have successfully extended contractor access for an additional 90 days.
