In a recent article about market adjustments for Segments 7 and 8 school construction projects in Cleveland, *Plain Dealer* reporter Patrick O'Donnell attributed to your office a statement that CMSD's anticipated reductions in state adjustments for market conditions were in error:

"The[ir] projections do NOT include adjustments that were made in favor of Cleveland Schools for segments 1-7 because we have not got to that point in the process for segments 8-10," he said. Asked if the OFCC was committed to giving the regional and Cuyahoga County adjustments for future construction here, Savors said it is.

Because we are actively educating and engaging the people of Cleveland around school construction projects in their neighborhoods, the public records request below is timely to ensure accuracy of the information shared with the public and reported in the media.
