I am a taxpayer in the Cleveland Metropolitan School District and pay for a bond issue that helps build and renovate schools for our children.

Our students, who live in one of the nation's poorest cities, need modern schools if they are to get a 21<sup>st</sup> Century education, compete in a global economy and have hope for the future.

I have been disappointed to learn that the Ohio Facilities Construction Commission (OFCC), which pays two-thirds of the cost of new buildings, has virtually eliminated allowances for Cleveland's higher construction expenses. This arbitrary shift goes against years of past practice and jeopardizes projects that are based on OFCC commitments.

I am asking you, as my elected representative, to contact the OFCC and demand it reverse this unfair decision. Please tell the commission to honor its commitment to Cleveland's children.
