

School Parent and Family Engagement Policy School Year 2024-2025

A. ANNUAL TITLE I MEETING

C. JOINTLY DEVELOPED

<u>Waverly</u> will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

Waverly will utilize monthly School Parent Organization (SPO) meetings to discuss family engagement programs, and Title 1 Part A required documentation with parents and other caregivers.
