

# School Parent and Family Engagement Policy School Year 2020-2021

In support of strengthening student academic achievement, Halle receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. #### A. ANNUAL TITLE I MEETING

<u>Halle</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

Considering ongoing concerns due to the Coronavirus (COVID-19), during the 2020/2021 school year, each school in the Cleveland Metropolitan School District will make the health and well-being of participants, staff, partners, and other guests a top

priority. During the 2020/2021 school year, all meetings will be held in alignment with the Ohio Public Health Advisory System (OPHAS) as follows:

- Level 1 Meetings can be held in person or not. Any meetings held in person will be done with strict adherence to health and safety guidelines (handwashing, hand sanitizing, wearing masks and following social distance guidelines of at least 6ft), to ensure to the extent possible prevention of the spread of the virus.
- Level 2, 3, and 4 All meetings will be held remotely and recorded to post on the schools website for viewing at a convenient time for all families, and staff.

• Halle School will host the annual Title I meeting on September 30<sup>th</sup>, 2020 virtually through Zoom.

## **B. FLEXIBLE NUMBER OF MEETINGS**

Halle will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, child care or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

Halle Pre-K-8<sup>th</sup> Grade School will host various parent Meetings and family nights.

- Halle Pre-K-8<sup>th</sup> Grade School will host Monthly Parent Advisory Committee Meetings which will be offered at times that are accommodating to our families. Halle Pre-K-8<sup>th</sup> Grade School will host a morning Parent Advisory Committee Meeting in the month of September and an afternoon Parent Advisory Committee meeting in October to survey which meeting is the best time for parents.
- Halle will host weekly "Tuesday Talks" virtually meeting via Zoom for parents to come and talk about any questions or concerns with virtual learning.
- Halle School will host the required 2 events per Quarter as laid out by the FACE office.
- The Family Nights/Parent Meetings will include topics aligned to the school's Academic Achievement Plan such as Inquiry Informational meetings that will focus on the schools newly adopted mode in the second year, Family Math Nights, Family Literacy Nights, K-3 Grade Parent Meetings with a focus on the 3<sup>rd</sup> Grade Reading Guarantee.
- Halle Pre-K-8<sup>th</sup> Grade School will also support families with Grade level transitions such as 8th Grade transition meetings, and 5<sup>th</sup> Grade Transition meetings.

• Halle Pre-K-8<sup>th</sup> Grade School will also host Grade level meetings that will be lead by the respective educators of the classrooms.

### C. JOINTLY DEVELOPED

Halle will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

• Monthly Parent Advisory Committee Meetings to discuss Family Engagement programs, and Title I Part A required documentation with parents and other Caregivers. The school will then plan activities with families that align with their needs and what is outlined in the School's Academic Achievement Plan.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

Halle Pre-K-8<sup>th</sup> Grade School will take the following steps to communicate effectively with families about upcoming Title I part A and other school related business:
