

In support of strengthening student academic achievement, **Cleveland School of the Arts** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. Cleveland School of the Arts agrees to implement the following requirements as outlined by ESSA Section 1116:

A. ANNUAL TITLE I MEETING

Cleveland School of the Arts will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

Considering ongoing concerns due to the Coronavirus (COVID-19), during the previous school years, each school in the Cleveland Metropolitan School District will make the health and well-being of participants, staff, partners, and other guests a top priority. During this current school year, all meetings will be held in alignment with the Ohio Public Health Advisory System (OPHAS) as follows:

- Level 1 – Meetings can be held in person or remotely. Any meetings held in person will be done with strict adherence to health and safety guidelines (handwashing, hand sanitizing, wearing masks and following social distance guidelines of at least 3ft), to ensure to the extent possible prevention of the spread of the virus.
- Level 2, 3, and 4 – All meetings will be held remotely and recorded to post on the schools' website for viewing at a convenient time for all families, and staff.

This annual meeting occurs during the annual Open House program as set by the school district calendar.

- **High School (Early Start) – August 18, 2022**
- **High School (Traditional) – September 14, 2022**
- **Pre-K to 8th Grade School – September 15, 2022**

During these sessions, other pertinent information regarding school policy, procedures, initiatives, and family events will be shared.

B. FLEXIBLE NUMBER OF MEETINGS

Cleveland School of the Arts will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

For the 2022-23 academic school year, CSA will convene monthly (primarily in-person) a Family Engagement Committee Meeting. This committee will consist of at least one administrator, faculty/staff representation, community partners, and at least one parent, to plan and support engagement events and activities.

We will further support this level of engagement with monthly and/or quarterly parent support group meetings. These support groups will vary in nature to support the family to understand and meet the academic needs of scholar. Parent groups will consist of a Senior Class Parent Group, and targeted Arts Discipline Parent Group. These groups will convene in-person or virtually from September to May of the school year.

C. JOINTLY DEVELOPED

- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.
