

# School Parent and Family Engagement Policy School Year 2023-2024

#### A. ANNUAL TITLE I MEETING

<u>Tremont Montessori</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

Considering ongoing concerns due to the Coronavirus (COVID-19), during the 2023\2024 school year, each school in the Cleveland Metropolitan School District will make the health and well-being of participants, staff, partners, and other guests a top

priority. During the 2023/2024 school year, all meetings will be held in alignment with the Ohio Public Health Advisory System (OPHAS) as follows:

- Level 1 Meetings can be held in person or remotely. Any meetings held in person will be done with strict adherence to health and safety guidelines (handwashing, hand sanitizing, wearing masks and following social distance guidelines of at least 3ft), to ensure to the extent possible prevention of the spread of the virus.
- Level 2, 3, and 4 All meetings will be held remotely and recorded to post on the schools' website for viewing at a convenient time for all families, and staff.

## Parents' Right to Know - Title 1A - ESSA

Parents have the right to know about the teaching qualifications of their child's classroom teacher in a school receiving Title 1 funds. You can request this information from your principal. Notification if your child is being taught for 4 or more weeks by a teacher who is not highly qualified. Whether the teacher has met state qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction. Whether the teacher is teaching under emergency or other provisional status through which state qualification or licensing criteria have been waived. Whether the teacher is teaching in the field of discipline of certification of the teacher. Whether your child is provided services by paraprofessionals and, if so, their qualifications.

## How can I support Title 1A Programs?

Participate in the Parent Advisory Committee (PAC). Ask to participate in the development of the Academic Achievement Plan (AAP). Attend Title 1A sponsored programs and activities, support your child's learning by creating a learning space for them to do schoolwork and exposing them to resources and enrichment opportunities in the community. Participate in family engagement activities and programs sponsored by the district like Parent University workshops and offerings.

#### B. FLEXIBLE NUMBER OF MEETINGS

<u>Tremont Montessori</u> will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).
