



School Parent and Family Engagement Policy

In support of strengthening student academic achievement, Bolton receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of the Every Students Succeeds Act (ESSA) Section 1116. A. ANNUAL TITLE I MEETING

Bolton will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

During Open House on September 11, 2025, from 6-8pm, during this time, we will share information about Building Brighter Futures, Get More 3.0, Math Night, Literacy Night, Father's Walk, and Parent Workshops.

B. FLEXIBLE NUMBER OF MEETINGS

Bolton will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

Family Engagement meetings will be held in the Fall, Winter and Spring. We will begin our Parent workshops in November. We are also working on a collaboration with local church groups to provide meals for families at Thanksgiving here at Bolton, as well as gifts for the holidays. Meeting will be held in-person here at Bolton and a virtual option will also be available. Chat and Chews will be held the 1st Wednesday of the month beginning in November at 10:30am.

C. JOINTLY DEVELOPED

Bolton will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

D. COMMUNICATION

Bolton will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

We will utilize our digital communication sign, IVRs, emails, phone calls, monthly bulletins and fliers to communicate with parents.

E. DISSENSION PROCESS

F. SCHOOL-PARENT COMPACT

H. ACCESSIBILITY

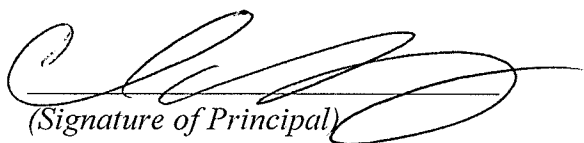
