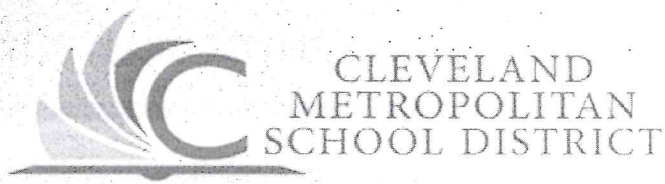
**Answer:** The project is slated to start once the vendor is selected and a fully executed contract is in place. It is slated to finish 90 days after the execution of the contract.
