This Addendum #3 reflects the following:

**Comprehensive Question and Answer List** 

1. Whether companies from outside USA can apply for this? (like, from India or Canada)

**ANSWER:** As long as all the requirements of the RFP and the international supplier is eligible to do business in the US and in compliance with all federal, state, and local laws and regulations.

2. Whether we need to come over there for meetings?

**ANSWER:** Yes attendance is required for some meetings.

3. Can we perform the tasks (related to RFP) outside USA? (like, from India or Canada)

**ANSWER:** As long as it is permitted by federal, state, and local laws and regulations.

4. Can we submit the proposals via email?

**ANSWER:** No. As per Section I: Instructions to Proposers # (1 and 2) RFP specifications All responses must be received:

5. What is the level or number of process changes do you make each quarter?
