

School Parent and Family Engagement Policy School Year 2022-2023

<u>Louisa Way Alcott</u> agrees to implement the following requirements as outlined by ESSA Section 1116:

A. ANNUAL TITLE I MEETING

Louisa May Alcott will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

Considering ongoing concerns due to the Coronavirus (COVID-19), during the 2022\2023 school year, each school in the Cleveland Metropolitan School District will make the health and well-being of participants, staff, partners, and other guests a top

priority. During the 2022/2023 school year, all meetings will be held in alignment with the Ohio Public Health Advisory System (OPHAS) as follows:

- Level 1 Meetings can be held in person or remotely. Any meetings held in person will be done with strict adherence to health and safety guidelines (handwashing, hand sanitizing, wearing masks and following social distance guidelines of at least 3ft), to ensure to the extent possible prevention of the spread of the virus.
- Level 2, 3, and 4 All meetings will be held remotely and recorded to post on the schools' website for viewing at a convenient time for all families, and staff.

B. FLEXIBLE NUMBER OF MEETINGS

Louisa May Alcott will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

PAC meetings will be held on the third Wednesday of every month. Additional meetings will be held during the month if participants feel the need for one.

C. JOINTLY DEVELOPED

Louisa May Alcott will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

The parent ambassador will have the opportunity to sit on the AAP committee to provide input. The monthly parent meetings will be used to as a platform to develop and discuss family engagement. Parent-teacher conferences will be used as quality time to disseminate information about the student's academic performance and attendance. The time will also be used to solicit ideas and suggestions for parents on the type of activities and events they would like to participate in at the school to secure their involvement.

D. COMMUNICATION

<u>Louisa May Alcott</u> will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

- ClassDojo, Schoology, social media, and a school newsletter will be used as a means of communication.
- A translator will be made available when necessary.

E. DISSENSION PROCESS

<u>Louisa May Alcoff</u> will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents and family members.

F. SCHOOL-PARENT COMPACT

<u>Louisa May Alcott</u> will take the following actions to jointly develop with parents and family members of enrolled children a school-parent and family compact that outlines how parents, families, school, staff, and students will share the responsibility for improved student academic achievement and develop a partnership to help children achieve the state's high standard and how the plan is used, reviewed, and updated.

The monthly parent meetings and other family events will be used as a platform to develop and discuss family engagement including the development of a school-parent compact.
