

School Parent and Family Engagement Policy School Year 2021-2022

In support of strengthening student academic achievement, <u>Marion-Sterling</u> receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. <u>Marion-Sterling</u> agrees to implement the following requirements as outlined by ESSA Section 1116:

A. ANNUAL TITLE I MEETING

Marion-Sterling will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school

parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

Considering ongoing concerns due to the Coronavirus (COVID-19), during the 2021/2022 school year, each school in the Cleveland Metropolitan School District will make the health and well-being of participants, staff, partners, and other guests a top priority. During the 2021/2022 school year, all meetings will be held in alignment with the Ohio Public Health Advisory System (OPHAS) as follows:

- Level 1 Meetings can be held in person or remotely. Any meetings held in person will be done with strict adherence to health and safety guidelines (handwashing, hand sanitizing, wearing masks and following social distance guidelines of at least 6ft), to ensure to the extent possible prevention of the spread of the virus.
- Level 2, 3, and 4 All meetings will be held remotely and recorded to post on the schools website for viewing at a convenient time for all families, and staff.

This meeting will be held at the first Open House of the School year. School policies and procedures will be shared. Additionally, the AAP goals will be shared, opportunities for involvement. A session will be offered on how to navigate the school website, where parent information including the parent handbook can be accessed. Finally, Say Yes Support Services will be presented to parents.

B. FLEXIBLE NUMBER OF MEETINGS

Marion-Sterling will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, child care or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

<u>Marion-Sterling School</u> will conduct Monthly SPO/PAC Meetings to rebuild active membership in the parent group on the third Wednesday of each month at 12:00pm.

Family Night will be held in the evening between 4:00-6:00pm for those who cannot attend daytime events.

C. JOINTLY DEVELOPED

Marion-Sterling will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

Marion-Sterling School will utilize time during the Monthly Parent Meetings to receive feedback from parents on Family Engagement programs, and to develop the Family, and Community Engagement Policy, and School Family Compact. Parents will be surveyed during parent meetings to gather data on activities they would like to participate in.

Members of Marion-Sterling School's Parent Group will be invited to participate in the schools Academic Achievement Plan Team and Family Engagement Committee to plan programing for parents based on the parent's, and scholar's needs.

<u>Marion-Sterling</u> will provide parents and families of participating children timely information about programs under Title I, including:

- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

<u>Marion-Sterling School</u> will provide IVR phone calls and text messages, Facebook/Instagram posts and Personal Invitations to parents about upcoming Family activities, and things that are occurring at the school or online. All modes of communication will be translated in Spanish based on need.

<u>Marion-Sterling School</u> will also send home a Monthly Parent Newsletter, and Calendar to keep parents informed about upcoming testing, family activities, and days schools will be closed.

E. DISSENSION PROCESS

<u>Marion-Sterling</u> will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents and family members.

<u>Marion-Sterling School</u> will utilize Parent-Teacher Conferences, and Open-House to provide updates on individual scholar's academic performance, as well as to review whole school Data.
