

# School Parent and Family Engagement Policy School Year 2024-2025

In support of strengthening student academic achievement, <u>William Rainey Harper</u> receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. #### A. ANNUAL TITLE I MEETING

<u>William Rainey Harper</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

## B. FLEXIBLE NUMBER OF MEETINGS

Present information at start of year Open House. Share information via Class DoJo, social media, school website. Have parent representation and information at parent teacher conferences. Principal Chat-n-Chew-monthly on first Friday (virtual and in person options).

<u>William Rainey Harper</u> will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

Use of class DoJo, school website, all social media pages, and IVR messaging. Class DoJo communications allow ESL families to translate messages. When available flyers and information will also be posted and most available for ESL families.

## F. SCHOOL-PARENT COMPACT
