The 2020-2021 Ohio’s State Test (OST) is rapidly approaching and, once again, we are looking forward to providing safe transportation service for your child/children to and from school.

Students will test at the East Professional Center - 1349 East 79th Street Cleveland, OH 44103. They will test between 10AM to 1PM on their assigned dates.

ITEMS REQUIRED ON TESTING DAY

Bring the CMSD-issued computer device each testing day

Students are required to bring their fully-charged CMSD computer each of the days they are scheduled to test. Please be sure to charge the device each night before testing.

Face Covering / Mask

CMSD requires that all examinees bring and wear a mask or face covering to prevent the spread of Coronavirus. Students will be prohibited from entering the testing facility without a face covering or a mask.

Grab and Go Lunch will be provided

Students may eat in a designated area on their break or prior to departure from the testing facility.
