



School Parent and Family Engagement Policy School Year 2022-2023

A. ANNUAL TITLE I MEETING

LINCOLN-WEST SCHOOL OF GLOBAL STUDIES will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

Considering ongoing concerns due to the Coronavirus (COVID-19), during the 2022\2023 school year, each school in the Cleveland Metropolitan School District will

make the health and well-being of participants, staff, partners, and other guests a top priority. During the 2022/2023 school year, all meetings will be held in alignment with the Ohio Public Health Advisory System (OPHAS) as follows:

- Level 1 – Meetings can be held in person or remotely. Any meetings held in person will be done with strict adherence to health and safety guidelines (handwashing, hand sanitizing, wearing masks and following social distance guidelines of at least 3ft), to ensure to the extent possible prevention of the spread of the virus.
- Level 2, 3, and 4 – All meetings will be held remotely and recorded to post on the schools' website for viewing at a convenient time for all families, and staff.

Description of the activity and how it will be implemented: In person, parents will be given the opportunity to meet the teachers and staff of the building, including support staff and members of the community. Parents will learn more about academic programming and social-emotional learning supports available to students and families during the remote learning model. During the event, caregivers will speak with their student's teachers regarding academic progress, receive information about school programs centered around academic and social-emotional goals for students; students learning experiences and opportunities. This is also an opportunity for the families to receive their student's schedule, dress code shirts, 1:1 laptops and technology accounts, school supplies, back-packs, and relative information of various SEL and Say Yes family resources and reviewing of the Title 1 Plans for the School Year 2021-2022.

What will families learn from this activity?

The goal of the activity is to continue building strong relationships between families and staff. Parents will -be invited to participate in meetings to learn about various elements and the five forms of experiential learning experience: (1) Competency-based education (2) Service Learning (3) Expeditions (4) College and Career Readiness (5) Exhibitions of Learning. Families will also learn more about the Say Yes to Education; intervention, enrichment and acceleration opportunities; and students' academic progress towards their Personalized Learning Plan focused on reading (writing) and math proficiency; and on-track to graduation. Families will learn more about the "Say Yes to Education" and reviewing of the Title 1 Plans for the School Year 2022-2023.


