



School Parent and Family Engagement Policy

In support of strengthening student academic achievement, **Franklin D. A. ANNUAL TITLE I MEETING

- **Franklin D. Roosevelt Academy** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

B. FLEXIBLE NUMBER OF MEETINGS

- **Franklin D. Roosevelt Academy** will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, child care or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

Franklin D. Roosevelt Academy will host monthly Parent Advisory Committee Meetings at times that are convenient for parents and guardians. Beginning in September through May 2024. All meetings will be held in a hybrid format to accommodate the schedules and needs of the parents. The times will be from 3:45p – 4:45pm

C. JOINTLY DEVELOPED

Franklin D. H. ACCESSIBILITY




