Each school year in the fall and spring, Ohio school districts administer the statemandated Ohio State Tests (OST). The Ohio Department of Education has not provided an option for districts to remotely administer the tests; therefore, the Cleveland Metropolitan School District must administer the tests in person.

Details on the Ohio State Tests:

- The tests are administered online, which means students will need to bring their district-issued laptops to school, fully charged, on their testing days. If you child does not have a laptop, or if it needs to be repaired, please contact our school at 216-838-5300.
- Each test has two parts and testing times range between 2.5-3.5 hours to complete. This is for the entire test and includes the time needed to review instructions, and distribute and collect materials.
- A Grab and Go Lunch will be available for students.

Please be advised of the following important information:

- $\checkmark$  If your child is ill or has a fever, please keep them at home.
- ✓ All students will enter through the gym door at 10:00 am and be picked up at the gym door at 1:00 pm (off the parking lot). Students will have their temperature checked upon entering. If you are transporting your child, please wait to ensure that he/she passes the temperature check before you leave. Students with a fever must return home. Students who come by bus and do not pass the temperature test will be placed in our Care Clinic until they can be picked up by you. We will not be able to provide transportation home.
- $\checkmark$  A face mask covering nose and mouth must be worn at all times, including on the bus.
- ✓ Further information on bus transportation will be provided when it becomes available. General times will be around 10:00am and 1:00pm.
