## **School Parent and Family Engagement Policy**

### **School Year 2022-2023**

In support of strengthening student academic achievement, **Alfred A. Benesch School** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. Parents and family members shall be notified of the policy in an understandable and uniform format and, to the extent practicable, provided in a language the parents and family members can understand. The policy establishes the school's expectations for parent and family engagement and describes how the school will implement a number of specific parental and family engagement activities.

**Alfred A. Benesch School** understands that parent and family engagement means the participation of parents and families in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- Parents and families play an integral role in assisting their child's learning

- Parents and families are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child

**Alfred A. Benesch School** agrees to implement the following requirements as outlined by ESSA Section 1116:

#### **A. ANNUAL TITLE I MEETING**

**Alfred A. Benesch School** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

Considering ongoing concerns due to the Coronavirus (COVID-19), during the 2022/2023 school year, each school in the Cleveland Metropolitan School District will make the health and well-being of participants, staff, partners, and other guests a top priority. During the 2022/2023 school year, all meetings will be held in alignment with the Ohio Public Health Advisory System (OPHAS) as follows:

- Level 1 - Meetings can be held in person or remotely. Any meetings held in person will be done with strict adherence to health and safety guidelines ( handwashing, hand sanitizing, wearing masks and following social distance guidelines of at least 3ft), to ensure to the extent possible prevention of the spread of the virus.
- Level 2, 3, and 4- Meetings can be held in person or remotely. Any meetings held in person will be done with strict adherence to health and safety guidelines ( handwashing, hand sanitizing,

wearing masks and following social distance guidelines of at least 3ft), to ensure to the extent possible prevention of the spread of the virus.

- Meetings may be held remotely and recorded to post on the school's website for viewing at a convenient time for all families, and staff based on current health guidelines and data.

#### **B. FLEXIBLE NUMBER OF MEETINGS**

**Alfred A. Benesch School** will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, child care or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

Monthly SPO meetings, Back to School Nights (August), Open House (September 23), Schoology Night (October), Literacy Night, Math Family Night (January), SEL Night (February), Testing Prep (March), Math for Moms/Digits for Dad (April)

#### **C. JOINTLY DEVELOPED**

**Alfred A. Benesch School** will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

For both remote and in person learning: parents can volunteer to read a story online or in the classroom, participate in and volunteer for Family Engagement Nights (Literacy, Math, etc.), parents can volunteer and participate in a schoolwide Career Day (if held).

#### **D. COMMUNICATION**

**Alfred A. Benesch School** will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

Parents can be informed through the use of a monthly newsletter, Dojo, Seesaw, Schoology, parent conferences, virtual phone calls, emails and text messages.

#### E. **DISSENSION PROCESS**

**Alfred A. Benesch School** will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents and family members.

**Alfred A.   - o how to monitor their child's progress, and
  - o how to work with educators to improve the achievement of their children.
- Educate school personnel, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents and families, in the value and utility of the contributions of parents and families, and in how to reach out to, communicate with, and work with parents and families as equal partners, implement and coordinate parent and family programs, and build ties between parents, families, and the school.

- Coordinate and integrate parental and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as family resource centers and materials that encourage and support parents and families to fully participate in the education of their children.


This School Parent and Family Engagement Policy has been developed jointly with, and agreed on with, parents and families of children participating in Title I, Part A programs.
