



**School Parent and Family Engagement Policy**

In support of strengthening student academic achievement, Willson receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy, agreed on by such parents, that shall describe the means of carrying out the requirements of The Every Student Succeeds Act (ESSA) Section 1116. **A. ANNUAL TITLE I MEETING**

Willson, will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parental involvement policy, the schoolwide plan, and the school-parent compact.

- The annual Title 1 meeting was held at the beginning of the school year, in conjunction with Open House. All information with regards to Title 1 was shared at that time including

information about the program, parent's requirements, school policies and procedures and any initiatives.

## **B. FLEXIBLE NUMBER OF MEETINGS**

Willson, will offer a flexible number of engagement meetings at convenient times for families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, child care or home visits, as such services relate to parental involvement).

- PAC meetings will be held monthly
- Families will be notified if the dates are changed for any reason
- Additional family events will be provided to continue building relationships among the building school staff and Willson families.

## **C. JOINTLY DEVELOPED**

Willson will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

A parent will be recruited each year to sit on the planning team for the AAP and be given the opportunity to give input. Their signature will be obtained on the document. The monthly parent meetings will be used as a basic platform to develop and discuss family engagement including the development of the school parent and family engagement policy. Parent/Teacher conferences will be used as quality time to disseminate information about scholar's academic performance, attendance, and behavior. This time will also be used to solicit ideas and suggestions from the parents on what type of activities and events they would like to participate in at the school to secure their involvement.

## **D. COMMUNICATION**

Willson will provide parents of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent programs, meetings, and other activities, will be sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand.

- IVR's, Facebook, flyers, Clasdojo, Schoology are used as a means of communication
- A translator/interpreter will be made available upon families' requests.

#### **E. DISSENSION PROCESS**

**Willson** will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents.

#### **F. SCHOOL-PARENT COMPACT**

The monthly parent meetings and other family events will be used as a basic platform to develop and discuss family engagement including the development of the school-parent compact.
