School Parent and Family Engagement Policy School Year 2024-2025

In support of strengthening student academic achievement, Euclid Park School receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. Parents and family members shall be notified of the policy in an understandable and uniform format and, to the extent practicable, provided in a language the parents and family members can understand. The policy establishes the school's expectations for parent and family engagement and describes how the school will implement a number of specific parental and family engagement activities.

Euclid Park understands that parent and family engagement means the participation of parents and families in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- Parents and families play an integral role in assisting their child's learning
- Parents and families are encouraged to be actively involved in their child's education at school
- Parents and families are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child

Euclid Park agrees to implement the following requirements as outlined by ESSA Section 1116:

A. ANNUAL TITLE I MEETING

Euclid Park will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

The Annual Title I Meeting will be held during the Euclid Park School's Open House. The budgetary amount for supporting parent engagement activities will be shared as well as the schoolwide budget with encouragement to participate in the school PAC. During the meeting parents will also be informed about the school's partnership with Verizon and Digital promise, thus the continued 1-1 technology and the continued use of the instructional model of blended learning. Additional information will afford parents about the use of Schoology and PowerSchool for connection and monitoring of their children's assignments, ODE and District testing resources and other parent resources.

B. FLEXIBLE NUMBER OF MEETINGS

Euclid Park will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

It is anticipated that the below meetings will be held during the 2024/2025 school year:

- Back to School Family Meet and Greet to be held the week prior to the 1st day of school.
- Fall Open House, Date TBD
- Parent Advisory Committee (PAC)- 1st meeting September 14th with an anticipated monthly evening meeting to be determined by parents/families.
- Verizon Innovative Learning Schools Quarterly Meeting to discuss and support digital citizenship.
- 8th Grade Parent Meeting to be held bi-monthly.
- Spring Career Fair with weeklong activities/meetings in May 2025
- Each quarter a Literacy, Math (Pi Night March 14th) and/or a Third Grade Guarantee Meeting to engage and inform parents of home strategies for assisting scholars.
- Parents will also have opportunities to attend the District's Parent University.

C. JOINTLY DEVELOPED

Euclid Park will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

Again, parents will be able to attend:

- Each quarter a Literacy, Math and/or a Third Grade Guarantee Meeting to engage and inform parents of home strategies for assisting scholars.
- Parents will also have opportunities to attend the District's Parent University.

As well as:

- Participate in the development of the Academic Achievement Plan (AAP)
- Be a member of the PBIS Committee
- Be invited to be part of the planning and improvement of the school policy during Open House and Parent Meetings.

D. COMMUNICATION

Euclid Park will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

 - o how to work with educators to improve the achievement of their children.
- Educate school personnel, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents and families, in the value and utility of the contributions of parents and families, and in how to reach out to, communicate with, and work with parents and families as equal partners, implement and coordinate parent and family programs, and build ties between parents, families, and the school.
- Coordinate and integrate parental and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as family resource centers and materials that encourage and support parents and families to fully participate in the education of their children.


H. ACCESSIBILITY


This School Parent and Family Engagement Policy has been developed jointly with, and agreed on with, parents of children participating in Title I, Part A programs.
