



## **School Parent and Family Engagement Policy**

### **School Year 2024-2025**

In support of strengthening student academic achievement, Marion C. #### **A. ANNUAL TITLE I MEETING**

## **B. FLEXIBLE NUMBER OF MEETINGS**

*PAC meetings will be scheduled on a monthly basis and will be shared on social media and Class Dojo. In addition, Parent-Teacher conferences and building-wide events will take place quarterly.*

## **C. JOINTLY DEVELOPED**

Seltzer will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

*Parents and families will be invited to participate in monthly PAC meetings. They will learn about school news, district initiatives, and ways to support their student in school.*

## **D. COMMUNICATION**

Marion C. Seltzer will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

*Class Dojo has translation services available and other materials will be translated through the Multilingual Multicultural Department.*

#### **E. DISSENSION PROCESS**

Marion C. Seltzer will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents and family members.
