Intervention Protocol

- Included in contract (Attachment 4)
- Tiered interventions, from Notice of Concern to Termination Review
- Separate from "Corrective Action Plans" which are part of ODE compliance review
- Table of Interventions "does not represent a mandatory linear escalation of steps and consequences..."

Renewal Process

- Charter bargain: Autonomy for Accountability
- Contract (page 16): "Governing authority shall undergo a high-stakes review prior to contract renewal or at least every five years."

- Next renewals: CLA, NWIS, VPC
- Process begins in Spring 2018; applications due end of August; decisions made by end of December 2019

ODE Annual Report/ CMSD Annual Report

ODE Annual Report

- Must be submitted to ODE and parents by 11/30 each year
- ODE dictates ratings and performance categories including an overall rating
- This year, CMSD included historical performance and prospect for renewal

CMSD Annual Report

- More aligned to CMSD frameworks
- Summarizes academic record over contract term
- Detailed reports to be released in early 2018
- Academic reports shared today for 4-8 schools

Recap of compliance so far

- Revised items for site visits based on new org. framework
- Fall visits went well
 - No return student records checks
 - Only a few need return special ed visits (see fall reports)
 - Must send Notices of Concern for these
 - No lost points on walkthroughs

Spring 2018 Site Visits

- Will be in January and February
- Highlights/differences from fall
 - Review spring org. framework items
 - Many more items than in the fall
 - Building walkthrough
 - No classroom observations
 - Teacher retention
 - Focus groups
 - Background
 - Will contact to schedule, find participants
 - Doing survey to revise questions from last time

June ODE compliance

- ODE has not released final compliance sheet
- Some policies need board approval
- Able to submit items starting now
 - Many will already have been collected
 - Will create Epicenter items for others ASAP
