

The Cleveland High School for Digital Arts Dress Code:

Shirts:

- Solid color short or long sleeve polo (These shirts have no more than 3-4 buttons)
- Solid color short or long sleeve button down shirt
- Solid color short or long sleeve turtleneck
- Colors: black, white, blue, red, green
- Size appropriate; not too tight or too loose



All shirts must be collared, solid colored, and tucked into pants. Exposed skin/under garments are NOT acceptable. Logos may be no larger than quarter size.

Pants:

- Solid colored pants– school uniform dress, corduroy, or dress style pants. **No yoga, sweatpants, denim, harem, or cargo pants permitted.**
- Colors: khaki/tan, gray, black, dark blue/navy, dark green
- Size appropriate; not too tight or too loose



Belts

- Belts must be worn (unless there are no belt loops)
- Colors: black, dark blue/navy, brown **No insignias or logos on belts.**



Shorts/Skirts/Skortts:

- Solid colored shorts, skirts, or skortts– school uniform dress, corduroy, or dress shorts, skirts, or skortts.
- Colors: khaki/tan, gray, black, dark blue/navy, dark green
- May be no shorter than 2" two inches above the knee. Slits in skirts may be no shorter than 2" inches above the knee.
- Size appropriate; not too tight or too loose



All pants/shorts/skirts/skortts must be solid colored and worn at the hip or above at all times. Exposed skin/under garments are NOT acceptable. No athletic or cut-off clothing.

Pullover/Sweaters/ Vest

- Solid color pullover, button-up sweater/cardigan, vest may be worn over a collared shirt.
- Colors: khaki/tan, gray, black, dark blue/navy, white, dark green
- **No Hoods**



Hoodies

- **Only hoodies obtained through TRUST card privileges are acceptable for students. (More information coming about TRUST card.)**
- **NO other hoodies are permitted.**



Hats/ Headgear/Jackets

Students are permitted to wear jackets and hats/headgear outside as weather permits. However, these items **MAY NOT BE WORN** inside of the building. Students must put hats/headgear, jackets, and other items identified as unauthorized by the Uniform Leadership Council in lockers upon arrival.

Shoes

- Closed toe
- Shoelaces must be worn for laceable shoes
- Heels may be no more than 2" two inches tall
- No backless sandals or flip flops
- No slippers (soft soles)

Backpacks/ IDs

- All backpacks and large handbags must be placed in lockers.
- Students must wear their IDs; it is a part of the uniform. Replacement IDs can be purchased at a fee from the district.

Physical Education Practice Dress Code

Just as the CHSDA provides guidelines for dress code in the classroom, it is important to project the image of professionalism in our physical education attire as well. Participating students are asked to abide by the following guidelines.

Tops

- No tank tops, camisoles, or sports bras may be worn as outer garments.
- Size appropriate; not too tight or too loose

Bottoms

- Pants and shorts should be in good repair and worn at the waist
- May be no shorter than 2" two inches above the knee.)
- Size appropriate; not too tight or too loose

Shoes

- Athletic footwear is required.

Jewelry

- All jewelry must be removed prior to arrival to the gym. (earrings, necklaces, rings, etc.)

Exposed skin/under garments are NOT acceptable. Attire should be free of messages and inappropriate logos.

Store of Choice

Parents can buy the uniform/dress code pieces at a store of their choice as long as it meets the requirements of the uniform/dress code. Uniform dress code can be found at SchoolBelles, Walmart, Sears, JC Penney's, and Target among other stores.

NOTE: See the Student Code of Conduct for more details.

Uniform Violation Consequences:

1st Offense: Warning/Parent Notification

- A phone call will be made to the parent/guardian.
- A copy of the dress code will be reviewed with the student, the student will sign a copy to be retained at school, and the student will take a copy home for parent/guardian to review.

2nd Offense: Parent Notification/Planning Center

- A phone call will be made to the parent/guardian.
- A copy of the dress code will be reviewed with the student, the student will sign a copy to be retained at school, and the student will take a copy home for parents to review.
- The student will report to the Planning Center until parent/guardian brings appropriate uniform.

3rd Offense: Parent Conference/ Planning Center

- A phone call will be made home to the parent/guardian.
- A meeting between school personnel, the student, and parent/guardian will be arranged.
- Student will spend the school day in the Planning Center.

Additional Offenses: After School Detention

- A phone call will be made home to the parent/guardian.
- The student will spend a 1 hour detention on the following Monday or Friday.
