




#### **Southeast Region: K-8 Metric Highlights**



- 22% of enrollment is in C-rated schools, though there are no A or B-rated schools.
- 78% of enrollment is at schools rated either a D or F, the second highest rate of any region in the city.





- The Southeast region has declined by 280 students (3.6%) since 2013 and is forecast to decline another 3% by 2022-23.
- Only 52% of students in the Southeast region attend a District school, among the lowest rates of any region.



■ 62% of District K-8 schools are above the minimum viability target of 360 students, but only three of 13 schools meet the desired size of 450 students.



- 72% of District K-8 seats are in use, leaving approximately 1,300 empty seats in District K-8 buildings in the region and close to 1,000 empty charter seats.
- With the opening of new K-8 buildings in the region this year, 95% of students attending District K-8 schools are served in buildings that are newly built since 2002.





2017-18 District and Charter K-8 School Locations by 2018 ODE Report Card Grades



Historical and Forecast Enrollment of K-8 Students Residing in the Southeast Region Attending a School Anywhere in the City




- District K-8 enrollment declined 8.6% from 2013 to 2017 while Charter schools gained 120 students.

2017-18 Enrollment by School Type and Location for Southeast Residents




- Only 52% of K-8 students residing in the Southeast region attend District schools over other options. This is among the lowest rates of any region. None of the top attended District schools are high performing.
- Of students attending District schools, 77% stay in the region which is among the highest rates of any region.

Heat Map of School-Aged Student Population with District and Charter K-8 School Locations



# Southeast Region: What percentage of District K-8 schools meet minimum enrollment targets?






- District K-8 schools with at least 360 students are more likely to have the resources to sustain the baseline desired learning and teaching experience. This minimum enrollment target is the equivalent of about 20 students per class with two classes for each grade level from kindergarten to 8th grade.
- Ideally, District K-8 schools would enroll closer to 450 students, or about 25 students per class with two classes for each grade level, allowing for funding necessary for a more vibrant and viable school program.
- 62% of District K-8 schools are above the minimum enrollment target of 360 students, but only three of thirteen regional schools meet the desired enrollment of 450 students.

2017-18 K-8 Enrollment Trend for Schools With Fewer Than 360 Students by 2017-18 School Locations





- Many of the schools with negative enrollment trends are also below the minimum viable enrollment target

#### 2017-18 District K-8 Building Utilization by Building Age




- Overall, 72% of District K-8 seats are in use, leaving approximately 1,300 empty seats in District K-8 buildings in the region and close to 1,000 empty charter seats.
- With the opening of the new K-8 buildings in the region this year, 95% of students attending District schools are served in buildings that are newly built since 2002. Only one of the District K-8 buildings in this region pre-date 2002.
- The 11 new buildings in operation in this region have enough capacity to serve all students forecast to attend District schools in this region with additional open seats remaining.

- There are 52 special education classrooms and 10 PreK classrooms in the region, which adjust capacity by 1,550 seats. Even with this adjustment, there are roughly 1,300 open seats.
- Charters in this region report close to 1,000 empty seats.






### Southeast Region: Where do students reside? AJ Rickoff: 49% of students reside within a mile






### Southeast Region: Where do students reside? Charles Dickens: 51% of students reside within a mile






### Southeast Region: Where do students reside? Charles Eliot: 33% of students reside within a mile






### Southeast Region: Where do students reside? Fullerton: 64% of students reside within a mile




### Southeast Region: Where do students reside? Jamison: 51% of students reside within a mile






### Southeast Region: Where do students reside? Miles: 41% of students reside within a mile






### Southeast Region: Where do students reside? Miles Park: 41% of students reside within a mile






### Southeast Region: Where do students reside? Mound: 49% of students reside within a mile






### Southeast Region: Where do students reside? Nathan Hale: 49% of students reside within a mile






### Southeast Region: Where do students reside? Stevenson: 46% of students reside within a mile






### Southeast Region: Where do students reside? Warner GLA: 15% of students reside within a mile
