

# School Parent and Family Engagement Policy School Year 2024-2025

In support of strengthening student academic achievement, **Remote School K8** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. # A. ANNUAL TITLE I MEETING

Remote School K8 will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

The Title 1 meeting will be held at the annual Open House to be held in September 2024.

#### B. FLEXIBLE NUMBER OF MEETINGS

# D. COMMUNICATION

**Remote School K8** will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

Monthly electronic newsletter, use of School Messenger to send phone calls, emails and text messages, updated website with current calendar, updates and forms, Schoology updates and calendar, Instagram and Facebook.

#### E. DISSENSION PROCESS

**Remote School K8** will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents and family members.

#### F. SCHOOL-PARENT COMPACT

**Remote School K8** will take the following actions to jointly develop with parents and family members of enrolled children a school-parent and family compact that outlines how parents, families, school, staff, and students will share the responsibility for improved student academic achievement and develop a partnership to help children achieve the state's high standard and how the plan is used, reviewed, and updated.

This will be discussed at Family Orientations and the annual Title 1 meeting in September. It will be emailed to all family members following the meeting and placed on the school website. During Open House and Parent Meetings families will be able to learn about the school goals and how they can support.
