Our Goals

Our Research Question:


How does Cleveland's current standing in relation to its surrounding environment affect the corresponding laws and regulations that are in place or could be ratified as well as the actions of communities and organizations?

Survey

In order to collect knowledge of the student population and their relation to Cleveland's environment, we created a survey asking questions about neighborhood recycling laws and participation in environmental clean ups. In total, we surveyed 40 ninth and tenth graders at our school. We attempted to discover a correlation between location of the student and their knowledge of environmental regulations in their area. We concluded that there was little correlation, but we discovered that awareness of environmental issues and what is done about them among the student population is poor.

Are there any recycling rules and/or fines where you live?

The survey graph above shows that the majority of survey takers were not aware of environmental regulations in their area. As well, 40% said they never participate in environmental clean-ups while only 5% said they often participate. From this it can be concluded that lack of awareness and participation are big concerns as they present a barrier to healthy environmental progress.

Observation

We attended the Sustainable Cleveland Holiday Meet-up at MOCA, in Dec 2018, and we learned about the accomplishments of the organization in the past and their goals for the final year of the project.
