

School Parent and Family Engagement Policy School Year 2022-2023

In support of strengthening student academic achievement, **Riverside School** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. A. ANNUAL TITLE I MEETING

Riverside School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

Considering ongoing concerns due to the Coronavirus (COVID-19), during the 2022\2023 school year, each school in the Cleveland Metropolitan School District will make the health and well-being of participants, staff, partners, and other guests a top

priority. During the 2022/2023 school year, all meetings will be held in alignment with the Ohio Public Health Advisory System (OPHAS) as follows:

- Level 1 Meetings can be held in person or remotely. Any meetings held in person will be done with strict adherence to health and safety guidelines (handwashing, hand sanitizing, wearing masks and following social distance guidelines of at least 3ft), to ensure to the extent possible prevention of the spread of the virus.
- Level 2, 3, and 4 All meetings will be held remotely and recorded to post on the schools' website for viewing at a convenient time for all families, and staff.

Riverside Schools Open House was held on September 23, 2021. We held a virtual Open House for all families in which we discussed school routines and protocols as well as Title I funds and how we use our funding. Families then had the opportunity to meet with each of their child's teachers in a remote room.

B. FLEXIBLE NUMBER OF MEETINGS

Riverside School will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

C. JOINTLY DEVELOPED

Riverside School will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

Utilize Class Dojo and ensure that 100% of families are connected. Each educator will post a minimum of 1 time per week keeping families informed on what is happening in classrooms. Administration will utilize Class Dojo to message families privately as well as use the School Story to keep families informed about important events and information school wide. Riverside will continue to use the district provided IVR system for additional messaging. Riverside keeps an active Instagram account to connect with families, scholars, and the greater community. The Riverside PTC has an active Facebook account that runs parallel messaging to Class Dojo. Riverside will also use Google Forms for a variety of family nights to determine interests as well as enlist volunteers. The Google form will be used for Literacy Night, STEAM Night, volunteers for field day as well as winter holiday gift shop. Google Forms were also used for our first Trunk and Trade clothing swap.

D. COMMUNICATION

Riverside School will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

Utilize Class Dojo and ensure that 100% of families are connected. Each educator will post a minimum of 1 time per week keeping families informed on what is happening in classrooms. Administration will utilize Class Dojo to message families privately as well as use the School Story to keep families informed about important events and information school wide. Riverside will continue to use the district provided IVR system for additional messaging. Riverside keeps an active Instagram account to connect with families, scholars, and the greater community. The Riverside PTC has an active Facebook account that runs parallel messaging to Class Dojo. Class Dojo translates into a over 30 languages. It allows our EL population to translate school based messages into native languages. Families also have the ability to write messages in their native language and Class Dojo will translate it to English.

E. DISSENSION PROCESS

Riverside School will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents and family members.

F. SCHOOL-PARENT COMPACT

Riverside School will take the following actions to jointly develop with parents and family members of enrolled children a school-parent and family compact that outlines how parents, families, school, staff, and students will share the responsibility for improved student academic achievement and develop a partnership to help children achieve the state's high standard and how the plan is used, reviewed, and updated.

Riverside's Parent Compact is developed during the first PTC meeting of the school year. This meeting is usually held in early August prior to school starting. This meeting is used to set the family calendar for the year and activities that the PTC will help support. It will then be posted to Class Dojo, uploaded to our website, and shared via social media accounts with all active families in September. Our Family Liaison will also share it during month family coffee chats.

G. BUILD CAPACITY OF PARENTS

Riverside School will build the parent and family capacity for strong family engagement to ensure effective engagement of parents and families and to support a partnership among the school and the community to improve student academic achievement through the following:

- Materials and training to help parents and families to work with their children to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
- Provide assistance to parents and families of enrolled children, as appropriate, in understanding topics such as the following:
 - o the State's academic content standards,
 - o the State's student academic achievement standards,
 - o the State and local academic assessments including alternate assessments,
 - o the requirements of Title I, Part A,
 - o how to monitor their child's progress, and
 - o how to work with educators to improve the achievement of their children.
- Educate school personnel, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents and families,

in the value and utility of the contributions of parents and families, and in how to reach out to, communicate with, and work with parents and families as equal partners, implement and coordinate parent and family programs, and build ties between parents, families, and the school.

The Family Engagement Policy was developed by Riverside's administration team, school secretary (current Riverside parent) and our Parent Ambassador.
