Summary

The following spreadsheet shows the revenue and expenditures by month for the General Funds as of April 30, 2016. The total revenues forecasted in the October five year forecast were \$714,496,034 and expenditures were \$720,972,680. The adopted budget approved by the Board in October was \$720,459,313 plus carryover encumbrances of \$15,421,513 for a total appropriation of \$735,880,826.

Revenue Summary

The Cleveland Metropolitan School District is forecasting \$714,496,034 in revenue within the General Fund for the 2016 fiscal year as shown on Figure 1. As of April 30, 2016 the District has received revenue in the amount of \$634,780,668. The District will need to collect another \$79,715,366 to reach its target.

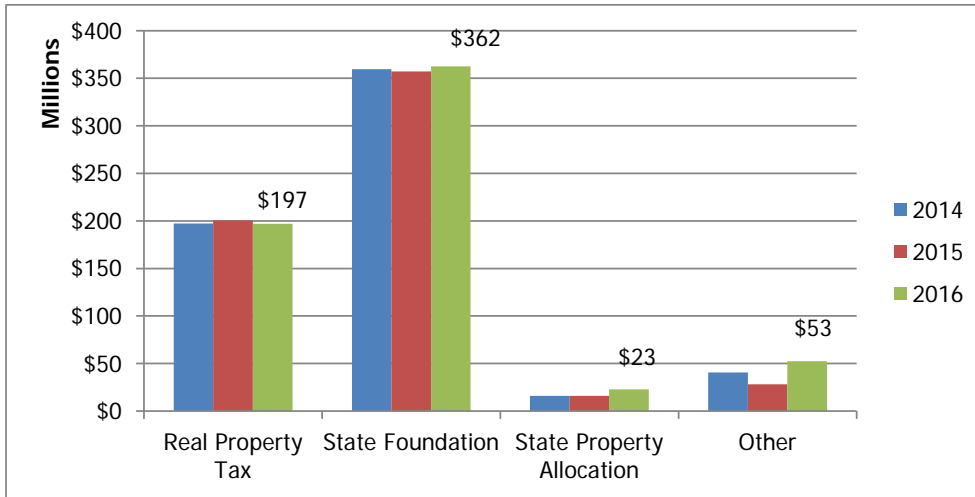

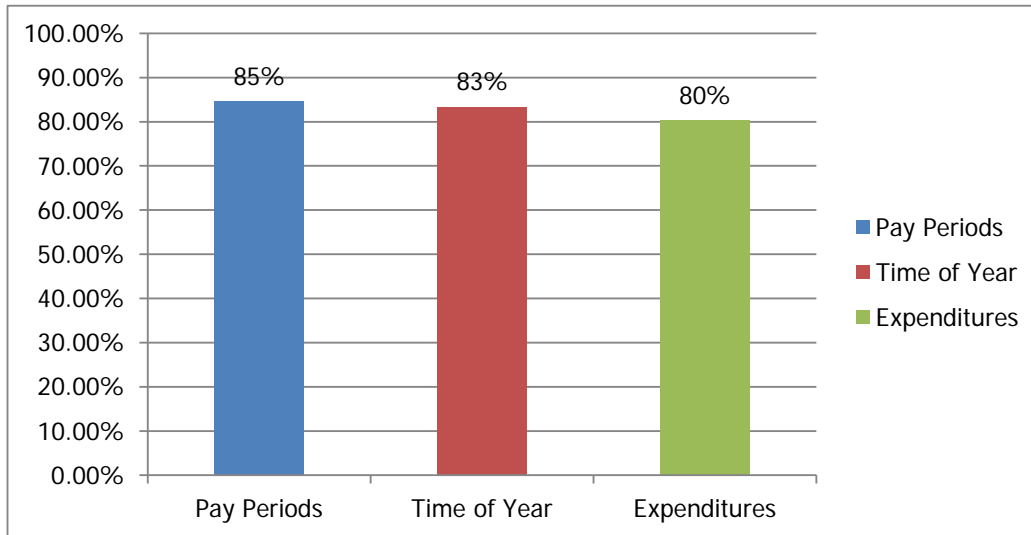

Expenditure Summary

The fiscal year 2016 adopted General Fund budget for the District is \$720,459,313. This budget, coupled with carryover encumbrances of \$15,421,513, resulted in a \$735,880,826 for FY 2016. The following information is a financial update of the status of this appropriation through April 30, 2016.

Through April 30, 2016 the District has expended \$578,526,994 and has outstanding encumbrances of \$21,743,344. This total of \$600,270,338 reflects 80.30% of the District's total appropriation (see Exhibit A). A statistical spending range for the District is based on two analyses: first, time elapsed is ten months, or 83.33%, of the fiscal year. Secondly, 22 of the 26, or 84.62%, of the total pay periods have passed. Figure 3 illustrates these points.

Figure 3: Encumbrance/Expenditure Level Through April



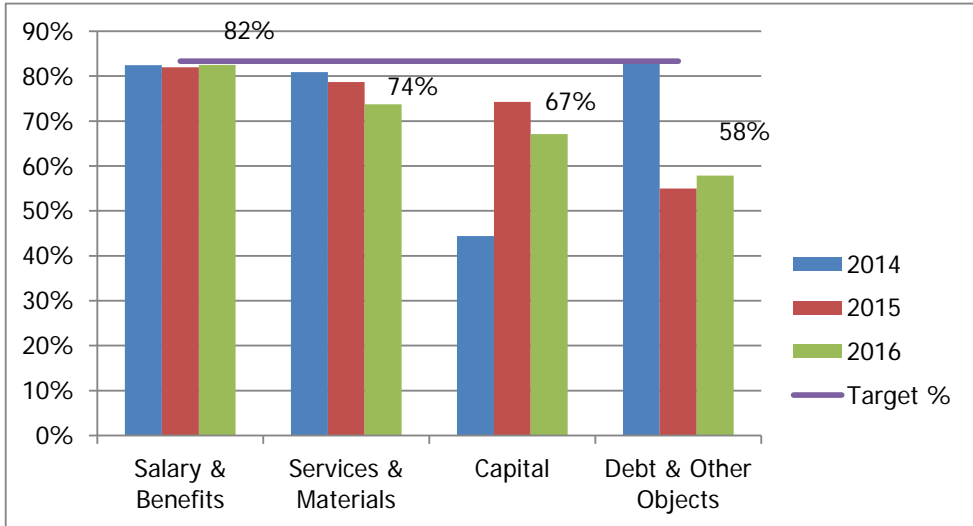
Overall, the District's encumbrance/expenditure level through April is below target based on the above analysis. As an examination of the categories of expenditures is performed, cyclical variances are noted between categories which relate specifically to school opening activities.

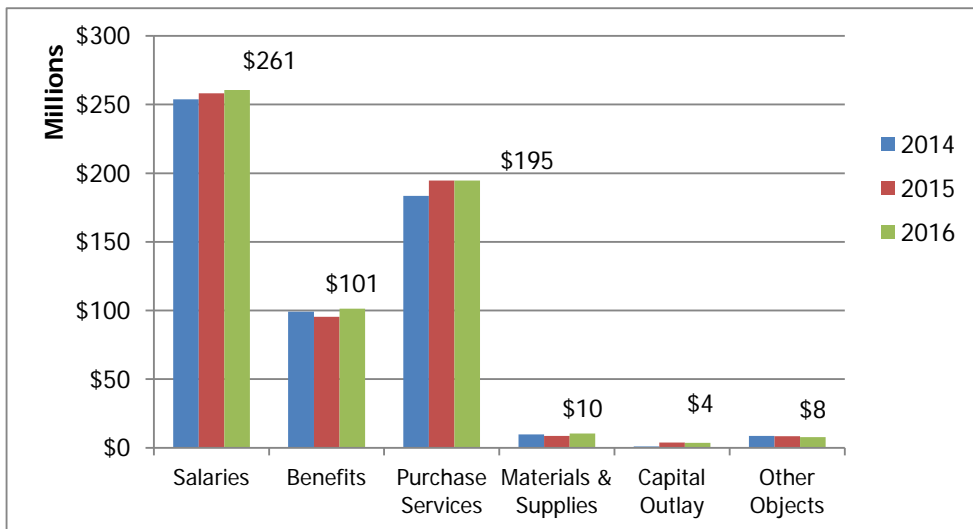

As Figure 4 and 5 illustrate, overall salaries and fringe benefits are on target for this time of year. Salaries are slightly higher than last year for this time of year which is primarily due to the differentiated compensation system and less open positions. Salaries are trending on budget. We will continue to closely monitor this area the remainder of the fiscal year. Salaries averaged \$11.7 million in April which is higher than the \$11.3 million average in March. Fringe benefits are slightly higher than last year for this time of year which is primarily due to healthcare. Health care costs are forecasted to increase 9% in FY 16 from FY 15.

The current year Purchased Services and Materials categories indicate a 74% encumbrance/expenditure level for this month. This is consistent with prior years and the cyclical nature of school operations.

The Capital encumbrance/expenditure level, whose budget comprises only .4% of the total General Fund budget, indicates a 67% encumbrance/expenditure level for this month. It should be noted that the vast majority of on-going construction projects are accounted for in other funds and therefore not reflected in the encumbrances/expenditures above.

Finally, the debt service and other objects category of encumbrance/expenditures, which mainly reflects the payment of principal and interest for the energy conservation notes and QZAB notes, treasurer and auditor fees, and the transfer of monies to other District funds (as required by State regulations), is as expected as of April 30, 2016. Debt payments occur in July and April while the transfer of monies to other District funds will occur in June.

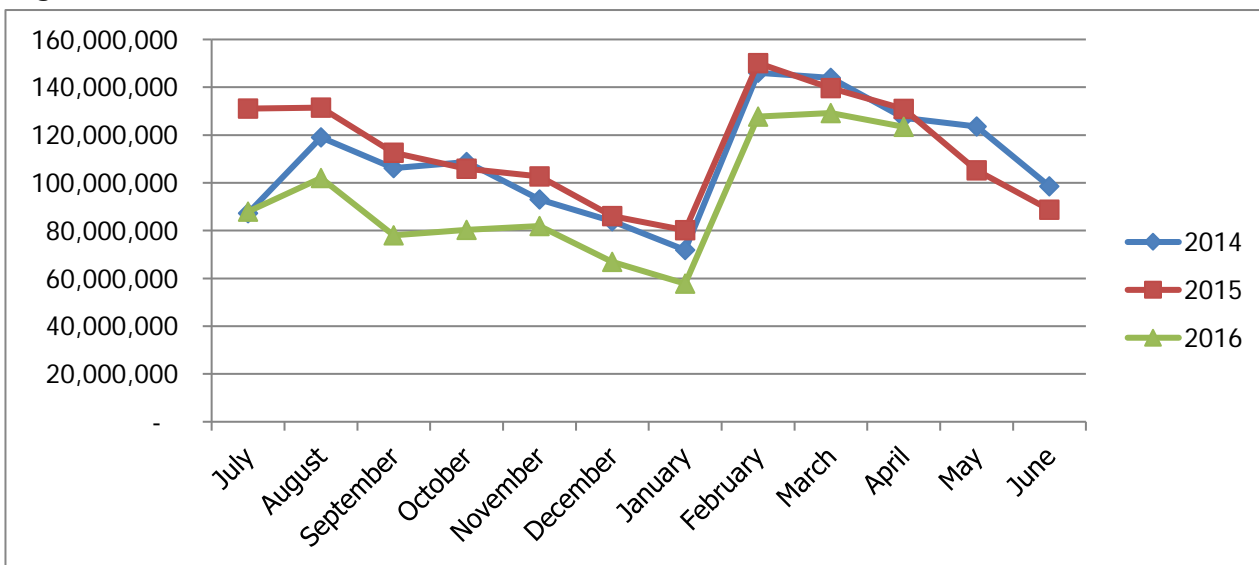
